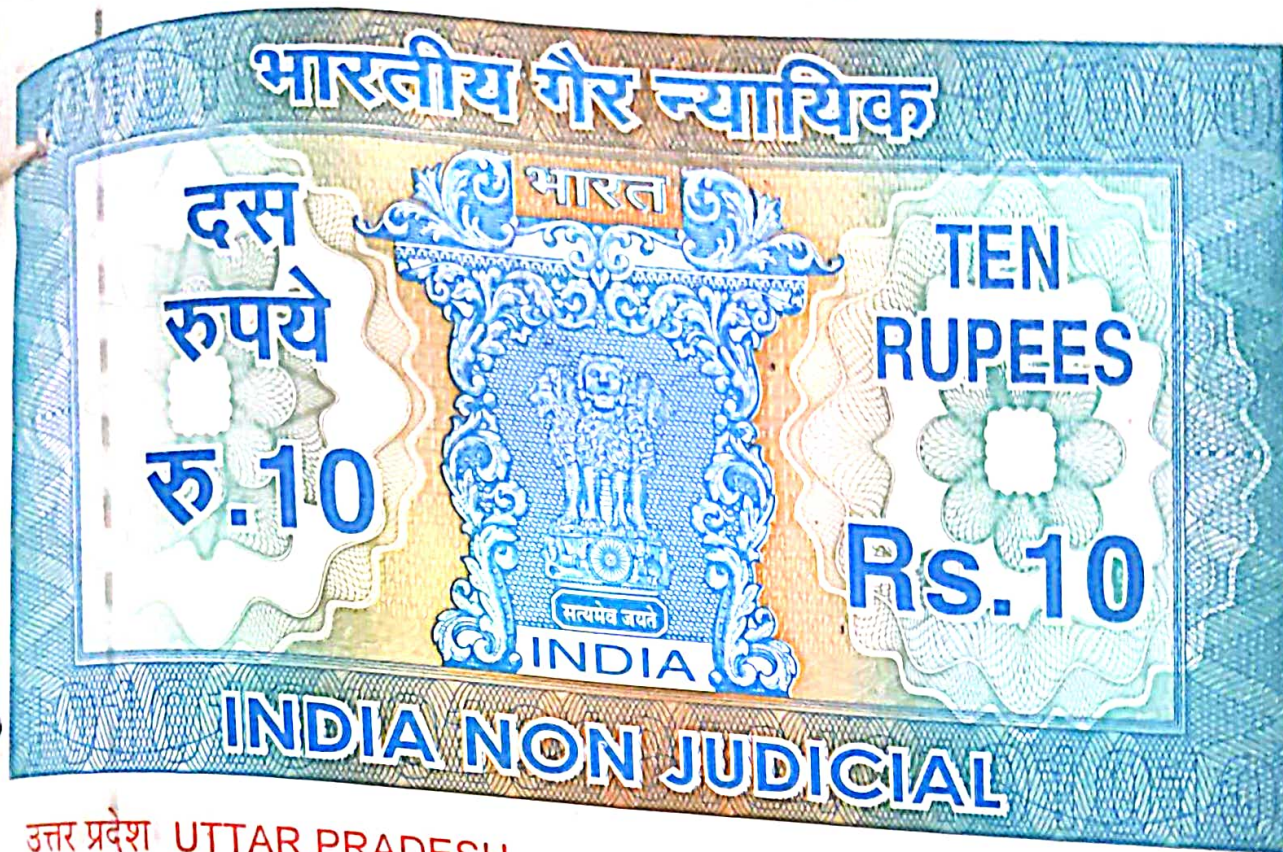

THIS Deed of Trust is made this 20 day of August 2011 between Mr. Ravindra Pratap Narayan Singh S/o Mr. Ram Ashray Singh, R/o Dilezakpur, opp. Indralok Talkies Gas Godown lane, Gorakhpur. (hereinafter referred to as Settler, whose expression shall unless repugnant to the context or meaning thereof be deemed to include their heirs, executors and administrators) of the first part; and

- 1) Mr. Ravindra Pratap Narayan Singh S/o Mr. Ram Ashray Singh, R/o Dilezakpur, opp. Indralok Talkies Gas Godown lane, Gorakhpur.
- 2) Mrs. Seema Singh D/o Late Ram Pyare Singh R/o Dilezakpur, opp. Indralok Talkies Gas Godown lane, Gorakhpur

hereinafter referred to as "TRUSTEES" which expression shall unless repugnant to the context or meaning thereof be deemed to include the survivors of them and the heirs, executors and administrator of the last surviving Trustee, her/his/her/assigns) of the second part.

Whereas the settler is possessed of and otherwise well and sufficiently entitled to the sum of Rs. 11000/- (Rupees Eleven Thousand Only).

And whereas the settler is desirous of making an educational trust for Socio-economic-cultural upliftment of the Society and to make it more knowledgeable.

And whereas the trustees above named have agreed to become the first trustees of this as testified by their being parties to and executing the deed of trust.

And whereas the said sum of Rs. 11000/- (Rupees Eleven Thousand Only) has in anticipation of this deed of trust been already handed over to the trustees before the execution of this deed of trust.

Now this deed witnesses that for the purposes of effectuating the said desire the settler has irrevocably transferred the said sum of Rs. 11000/- (Rupees Eleven Thousand Only) to the trustees being administrator for the said trust subject to the uses and trusts hereinafter mentioned. (The transfer where of the trustees does and each of them hereby admit and acknowledge);

- 1) The Trust shall be called "**SHRI BALAJI EDUCATIONAL TRUST**".
- 2) Registered head office of the trust shall be at Dilezakpur, opp. Indralok Talkies Gas Godown lane, Gorakhpur.

The trust has been created with the object of providing educational facilities to poor & middle class income group population and for that purposes running Schools, Colleges, Universities, Hostels, Educational research & Cultural centres, Lab. Games unit & other institutions related to these objects so as to benefit society & nation and it shall be lawful and competent for the trustees to give donations to other like trust & institutions and the trust shall be for the benefit of all persons belonging to whatever community irrespective of caste, creed or religion. The main motive of the trust would not be profit earning on commercial lines. Subject to above, objects would also include: -

- (i) To give financial assistance to such Schools, Colleges, Hostels, Libraries etc. which are not established for the purpose of earning the profits.
- (ii) To give all types of financial assistance for development of education.
- (iii) To give financial assistance to any person, body, institution or disabled and needy persons of the society.
- (iv) To help poor and weaker person/section of society for their social, economical and educational upliftment.
- (v) To arrange scholarship for needy, poor and meritorious students.
- (vi) To promote & assist for creating good environmental conditions.
- (vii) To do all such other acts including training camps, seminars & awareness programs which are helpful in attaining the aforesaid objects

### 4) BOARD OF TRUSTEES: -

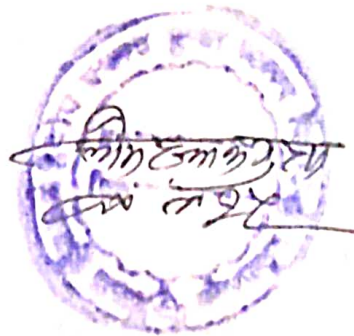
- i) A board of trustees shall govern the trust. The board of trustees shall consist of all the trustees the number of which shall always be not less than two and not more than fifty one.
- ii) The trustees may elect or nominate one of them as the chief managing trustee and also one of them as managing trustee of the board of trustees. The first such trustee Mr. Ravindra Pratap Narayan Singh & Mrs. Seema Singh will be the chief Managing Trustee & Managing Trustee respectively of the trust.
- iii) The first trustees as such including their/his/her successors & assigns described at the very outset, shall hold office for life-time and other co-opted/nominated trustees under this deed shall hold office for the three years unless re-opted/re-nominated under the provisions of this deed.

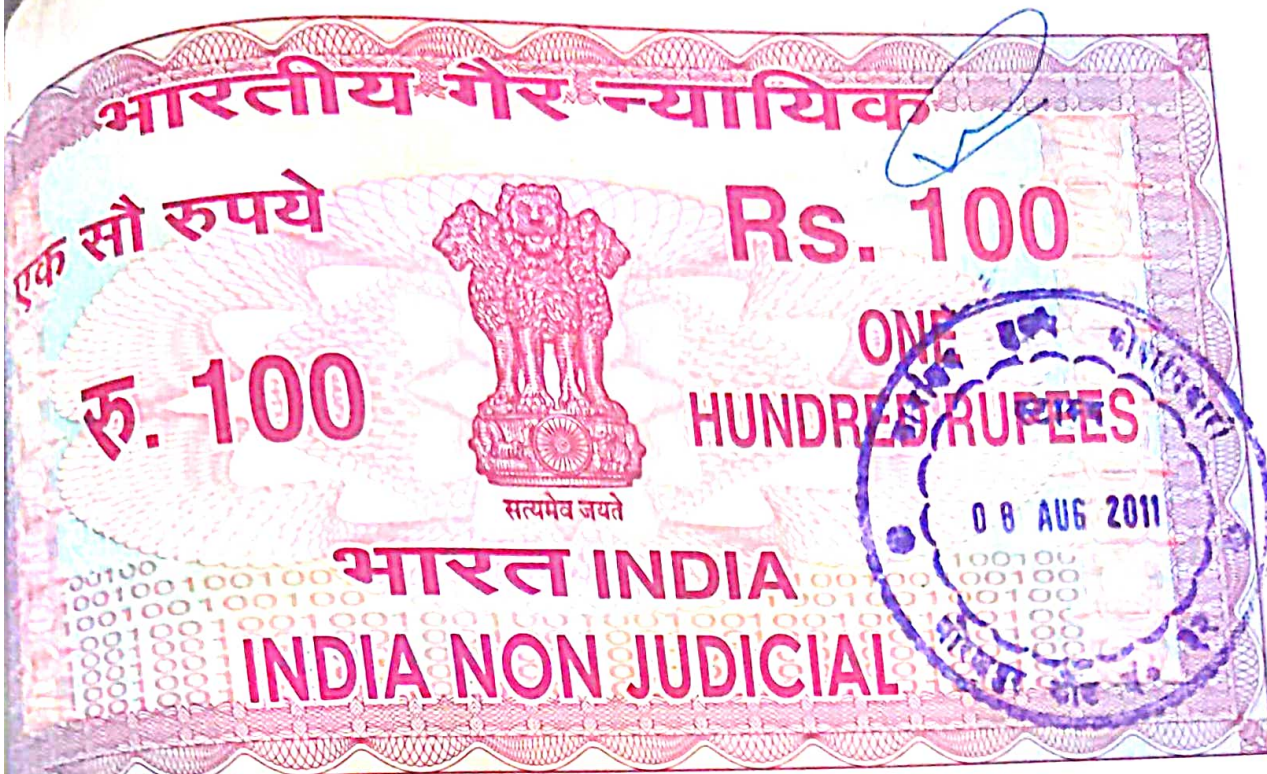

**POWERS & FUNCTIONS OF THE TRUSTEES: -**

On execution of this deed the trustees shall take charge of the said sum of Rs. 11000/- (Eleven Thousand Only) and it will be the corpus of fixed property of the trust, and it shall not be disposed of or subjected to any kind of charge for the purposes unless otherwise resolved unanimously by the board of trustees.

The trustees shall stand possessed of the said property of corpus and such other properties (both movable and immovable) as may be acquired from time to time by the trust by purchase exchange, grant, subscriptions, endowment, donation, contribution, or in any manner, whatsoever (all of which shall be designated as "the trust properties") on the trust herein mentioned.

The trustees shall have power to raise funds by accepting any voluntary contributions, donations, grant and aid in cash or in kind on such terms and conditions as the trustees deem fit for fulfillment of the objects of the trust.

The trustees shall have power to raise funds by accepting any voluntary contributions, donations, grant and aid in cash or in kind on such terms and conditions as the trustees deem fit for fulfillment of the objects of the trust.

It shall be competent for the trustees from time to time to frame, make and enforce all such rules, regulations and/or by-laws which is not inconsistent with the express provisions of this trust as the trustees may deem proper for securing and facilitating administration and management in detail of the various departments relating to the activities and affairs of the trust.

The trustees shall have power in general to acquire all things and do all acts necessary to carry out the object of the trust.

The trustees shall be entitled to reimburse themselves out of trust estate all expenses incurred in or about the execution of the trust of powers herein or in carrying out the trust, its objects and affairs. The trustees shall be entitled to be indemnified by the trust properties, against the consequence of all lawful acts done by the trustees in the course of and discharge of their duties as the trustees.

- viii) The trustees may at any time invite and receive or without such invitation receive any voluntary contribution or contributions either from the settler or from the trustees or from any one or more of them or from any other person or persons by way of donations.
- ix) The trustees shall also have power to invest in Government Securities or in any other approved manner and also to invest in such manner as may be directed by the Board of trustees.
- x) The trustees shall have power to open account in any form in any nationalized bank, and same will be operated singly and/or jointly by the Trustee.
- xi) For the purposes of carrying out of object of the trust, the trustees shall have power to take properties on lease or otherwise and immovable properties of any tenure and in case of vacant land the trustees shall be at liberty to erect building thereon and to do all acts necessary and incidental thereto.
- xii) The trustees shall be entitled to enter in any agreements or covenant with the owners of or persons entitled to or interested in any other properties and to raise fund by way of loans.
- xiii) The inter-control, regulation, management, application and administration of the trust properties whether capital or income, rent, interest or profit of any kind shall be in the discretion of the trustees.

### 6) SPECIAL PROVISIONS RELATING TO INSTITUTIONS: -

- i) That the trust will be abide the Rules, Regulations and Direction/Institutions issued by Central and/or State Government for establishing and running the schools, colleges including degree college, medical college, engineering college and university and also in case of recognition/affiliation from State's Education Boards, C.B.S.E., I.C.S.E., I.S.E.
- ii) That the registration of trust or society as applicable and the affiliation be got renewed from time to time.
- iii) That a number from the Directorate of education will be included in the management committee of the institutions.

That the 10% admission will be reserved for the Schedule Caste (SC)/ Schedule Tribe (ST) and Other Backward Class (OBC) for the talented students and fee will be charged from them as per the directions and orders issued by concerned education boards.

That if the institution is already recognized with U.P.S.B. said recognition will be cancelled as institution is affiliated/recognized with C.B.S.E. New Delhi.

That the Institution will pay the salary to their staff as per the norm fixed by the concerned department.

That the institution will keep the records of the service conditions and appointment of the staff and also sanction pension benefits to them as applicable under the rules.

That the records will maintained strictly as per the orders of concerned authorities.

That no amendments will be allowed in the above terms and conditions without the permission of the concerned department.

**MEETING: -**

i) That the settler of the trust shall during his life so long as he shall remain trustee of this deed be and have the privileges of the chairman of every meeting of trustees at which he shall be present and it shall not be competent for the trustees by any rules made or resolution passed by them or otherwise to deprive him of his right but he may waive such right when and so often as he may please.

ii) After the life time of settler the elder serving son of the settler will be the chairman and thereafter their senior (senior in Age) legal successor will be the Chairman.

iii) All the matters arising at a meeting of the trustees will be decided by majority of votes and in case of equality of votes the chairman of such meeting shall have a second or casting vote.

iv) It shall be lawful for the trustees to decide by circulation and any such resolution or decision shall be effective as resolution passed at a meeting of the trustees.

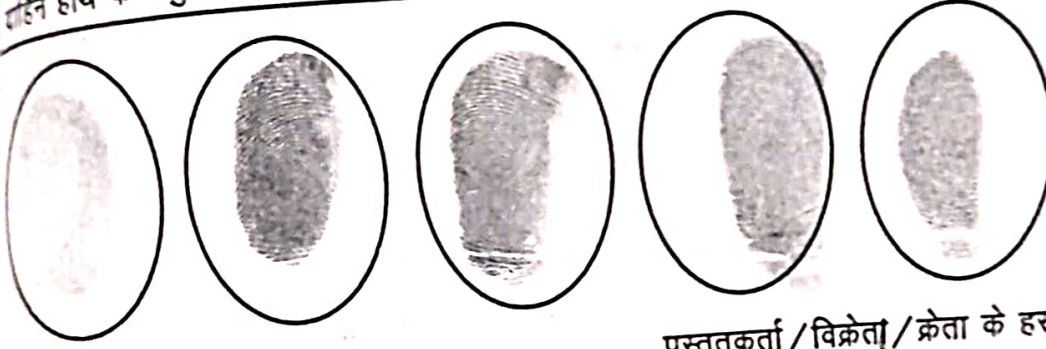

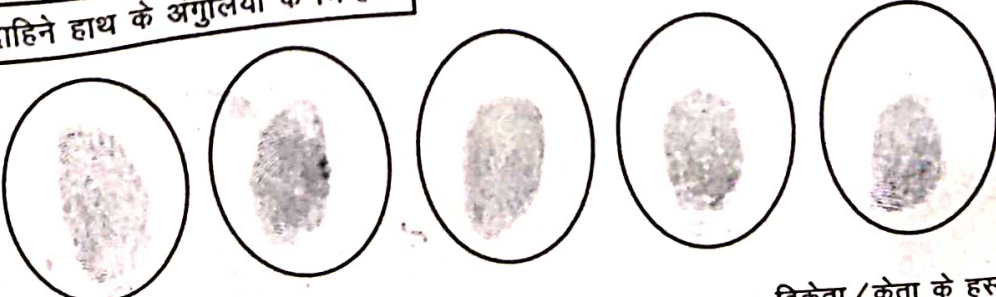

OTHERS:-

The trustees shall maintain proper and regular books of accounts of all receipts and expenditure of the trust.

On the 31<sup>st</sup> day of March every year a general account shall be taken of all the assets and liabilities of the trust and that of all entities owned by the trust and an income and expenditure account for the whole year and a balance sheet as on 31<sup>st</sup> March shall be prepared and shall be passed by the trustees. The accounts of the trust shall be passed by the trustees. A Chartered Accountant appointed by the trustees for the purpose shall audit the accounts for the trust annually.

In case of death, inability, resignation or refusal on the part of any trustee to act, as such trustee the remaining trustees shall be entitled to nominate any other person as they may think fit and proper to act as trustees in place of the trustee so dying or refusing to act or being unable to act. Provided that trustee so appointed will have the same powers and right as if he was originally appointed trustee under these presents.
